STATEWIDE 2011 - 2012 SUMMARY TRENDS

- ★ Michigan experienced a **5.3** percent increase in traffic fatalities, a **1.8** percent decrease in injuries and a **3.6** percent decrease in crashes.
- ★ Deaths among vehicle occupants (drivers and passengers only) increased **6.6** percent.
- ★ Persons sustaining "A" level injuries (the most serious) decreased **0.5** percent.
